

ORDINANCE NO. 2463

**AN ORDINANCE OF THE CITY OF ERLANGER IN KENTON COUNTY KENTUCKY  
AMENDING THE PAY PLAN TO INCLUDE THE POSITIONS OF  
POLICE SOCIAL SERVICES COORDINATOR  
AND  
ADMINISTRATIVE GRANT MANAGER**
