COMMITTEE DISCUSSIONS

Animal Control Ordinance- Council Member Meyer

- ➤ Discussion Mr. Kremer advised that Kenton County had asked cities to repeal their animal ordinances and adopt the County's ordinance instead; staff reviewed the City's ordinance and made changes to adopt the County's ordinance while making additions to meet Erlanger's needs; he advised that Kenton County was okay with this process
- ➤ Action Requested Mr. Meyer requested a possible first reading of the amended ordinance at the November 10, 2020 special council meeting; Mr. Gatlin advised that the penalty section may change; Mr. Cahill requested research regarding the addition for electric fences and signage

Energy Franchise - Council Member Meyer

- > Discussion Mr. Kremer explained the bidding process for the energy franchise
- ➤ Action requested Mr. Meyer asked that the franchise fee be separated from the energy franchise, Mr. Gatlin advised that he wasn't sure if this could be done, but could change the wording; possible first reading of the amended ordinance at the November 10, 2020 special council meeting

Nuisance Ordinance - Council Member Tyson Hermes

- ➤ Discussion Mr. Hermes and City Council reviewed the nuisance ordinance and Mr. Hermes' amendment recommendations, Mr. Gatlin took notes of amendment requests
- ➤ Action requested Mr. Hermes requested the first reading of the amended ordinance, with the proposed language as noted by Mr. Gatlin, at the November 10, 2020 special council meeting

<u>Council Committee Meetings - Council Member Tyson Hermes</u>

- ➤ Discussion Mr. Hermes discussed three options regarding council committee meetings: Option 1 - Leave the committee meetings as currently structured Option 2 - Increase the number of council members on each committee and assign two chairs Option 3 - Change council committees to a council caucus
- Action requested Discontinue discussion at this time and address in January 2021 with new council
