

SPECIAL MEETING
ERLANGER CITY COUNCIL
May 11, 2021

Mayor Jessica Fette called the special meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, May 11, 2021.

The following Members of Council were present: Jennifer Jasper, Stephen Knipper, Vicki Kyle, Gary Meyer, Diana Niceley, Rebecca Reckers, Don Skidmore, and Renee Skidmore. Council Member Vicki Kyle participated virtually. Council Members Kathy Cahill, Tom Cahill, Ryan Nicole Elmore, and Tyson Hermes were not present.

Also present were: Mayor Jessica Fette, City Administrator Matt Kremer, City Clerk Sherry Hoffman, and Attorney Emily Walters.

DISCUSSION

Waste Collection Bids were Discussed:

- Fuel Charge Clarification
- Bid Options
 - ❖ Weekly vs biweekly voluntary recycling
 - ❖ Included or voluntary recycling
 - ❖ Overall best option for residents

LEGISLATION

Ms. Walters read Municipal Order No. 05-11-21-01 authorizing the Mayor to enter into an agreement for the exclusive use of public streets and rights of way of the City, for the collection and disposal of all solid waste from property of the City and collectible solid waste from all residential collection units within the City.

1. M/S, Knipper-Meyer, to adopt the municipal order as read and to enter into an agreement with Rumpke for basic once a week waste collection for \$15.45/month and voluntary bi-weekly recycling collection for \$3.00/month. Four ayes (Jasper, Knipper, Niceley, D. Skidmore), four nays (R. Skidmore, Kyle, Meyer, Reckers), motion tied. Mayor Fette voted nay. Motion failed.
2. M/S, Reckers-Jasper, to adopt the municipal order as read and to enter into an agreement with Rumpke for basic once a week waste collection for \$15.45/month and once a week voluntary recycling for \$5.50/month. Three ayes (R. Skidmore, Jasper, Reckers), five nays (Kyle, Knipper, Niceley, Meyer, D. Skidmore), motion failed.
3. M/S, Meyer-Kyle, to adopt the municipal order as read and to enter into an agreement with Republic Services for basic once a week waste collection for \$14.35/month and voluntary bi-weekly recycling at \$6.50/month. Two ayes (Kyle, Meyer), six nays (R. Skidmore, Jasper, Knipper, Niceley, Reckers, D. Skidmore), motion failed.
4. M/S, Meyer-Niceley, to adopt the municipal order as read and to enter into an agreement with Rumpke for basic once a week waste collection for \$15.45/month and voluntary bi-weekly recycling collection for \$3.00/month. Discussion ensued. Mr. Meyer withdrew his motion.
5. M/S, Reckers-Knipper, to adopt the municipal order as read and to enter into an agreement with Rumpke for basic once a week waste collection for \$15.45/month and once a week voluntary recycling for \$5.50/month. Six ayes (R. Skidmore, Jasper, Knipper, Niceley, Reckers, D. Skidmore), two nays (Kyle, Meyer), motion carried.
