## ORDINANCE NO. 2494

ORDINANCE MODIFYING SECTION 31.02 OF THE ERLANGER CODE OF ORDINANCES AND ORDINANCE NO. 2156 RELATED TO COMPENSATION OF ELECTED OFFICIALS

**WHEREAS**, the elected officials have kept the same compensation, with CPI adjustments, since May 23, 2000; and

WHEREAS, the City Council of Erlanger desires to encourage attendance of all council members at all regularly scheduled meetings; and

WHEREAS, these changes will not be in effect until January 1, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ERLANGER, KENTUCKY, AS FOLLOWS:

Underlined portions are to be added and portions stricken are to be removed.

#### **SECTION I**

### § 31.02 COMPENSATION OF ELECTED OFFICERS

- (A) The <u>base</u> compensation of each member of the City Council is hereby established at the sum of \$3,167.76 per year, payable in equal monthly installments. <u>Each member of the City Council shall also receive \$50.00 per regularly scheduled City Council Meeting, Special Meeting of the City Council, and regularly scheduled City Council Committee Meetings. This meeting pay will be up to a maximum of \$100 a month for each City Council member. There shall be two (2) paid absences allowed per calendar year.</u>
- (B) In order to equate the compensation of the Mayor and the members of the City Council with the purchasing power of the dollar, such compensation shall be adjusted annually according to the computation of the annual increase or decrease in the Consumer Price Index of the preceding current year by the Department of Local Government pursuant to KRS 83A.075, and each such adjustment shall be made on July 1st of each year. retroactive to the first day of the ealendar year thereof. The adjustment shall only be for the base compensation and not the per meeting pay.

#### **SECTION II**

That if any section, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or otherwise invalid, such infirmity shall not affect the validity of the remainder of the Ordinance.

#### CERTIFICATION
