

ORDINANCE NO. 2495

AN ORDINANCE OF THE CITY OF ERLANGER, IN KENTON COUNTY KENTUCKY, AMENDING ORDINANCES 2197 AND 2246 AND SECTION 34 OF THE CODE OF ORDINANCES TO ADJUST THE AMOUNT OF THE ANNUAL ~~EDUCATIONAL~~ POST SECONDARY EDUCATION SCHOLARSHIP.

WHEREAS, the City of Erlanger desires to adjust the scholarship amount provided to the recipient to accommodate the current value of the dollar since the scholarship was established in 2002;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ERLANGER, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

Section 1.0 Increase of Scholarship Amount Provided

During the month of ~~April~~ May in each calendar year ~~after 2001~~ beginning in 2020, the city shall award one scholarship of ~~\$1,500~~ \$2,500, to be paid to an accredited post secondary educational institution on behalf of an eligible applicant therefore, at such times and in such amounts that are determined by the city, but no later than one year after the award. The Executive Branch of the City of Erlanger shall promulgate rules and procedures for the administration of the scholarship and appointment of Judges.

Section 2.0

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect if they remain valid in the absence of those provisions determined to be invalid.

Section 3.0

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section 4.0

This ordinance shall be effective as soon as possible according to law.


Section 5.0 - Publication
