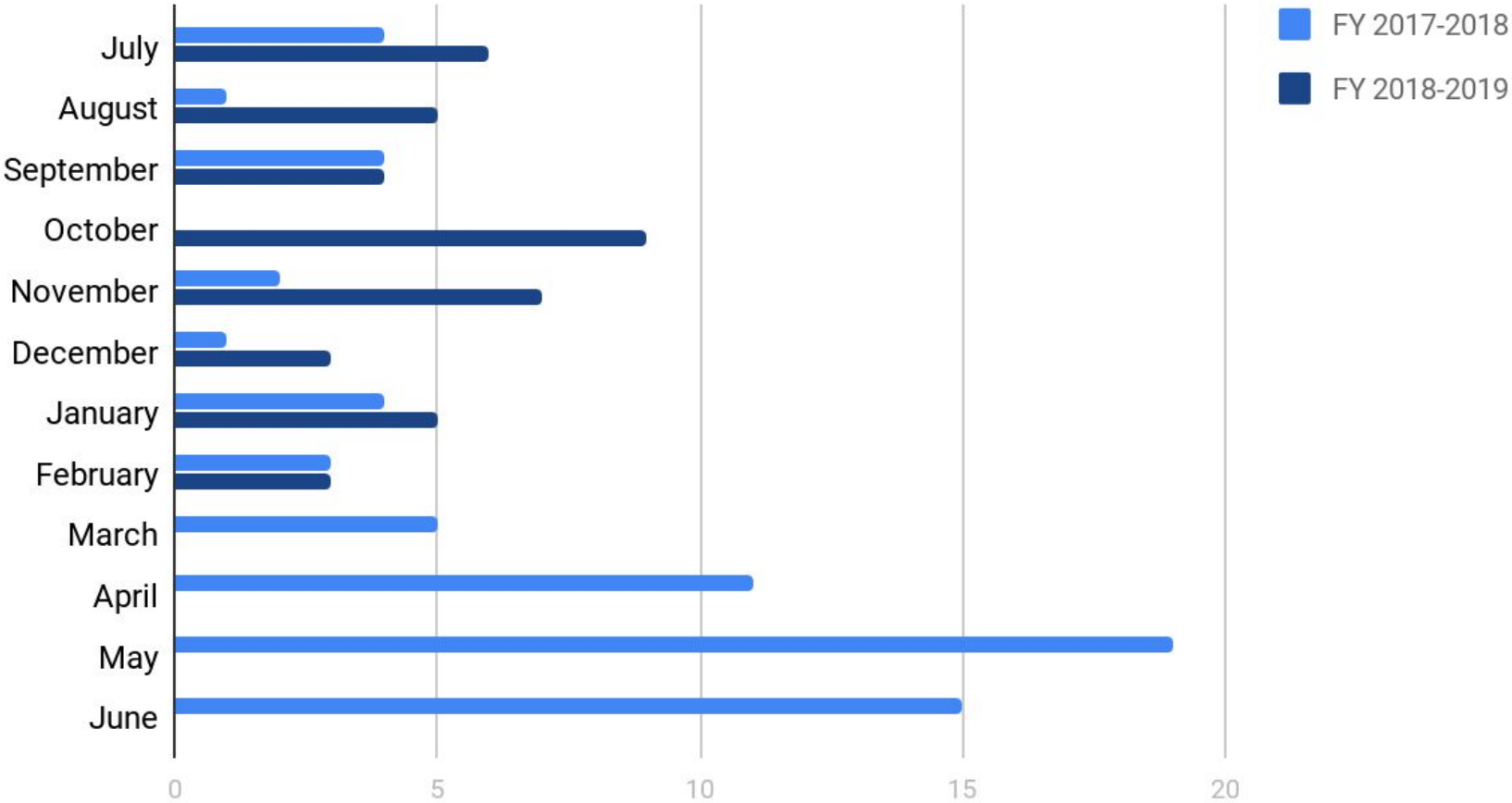

Important Reminders/News

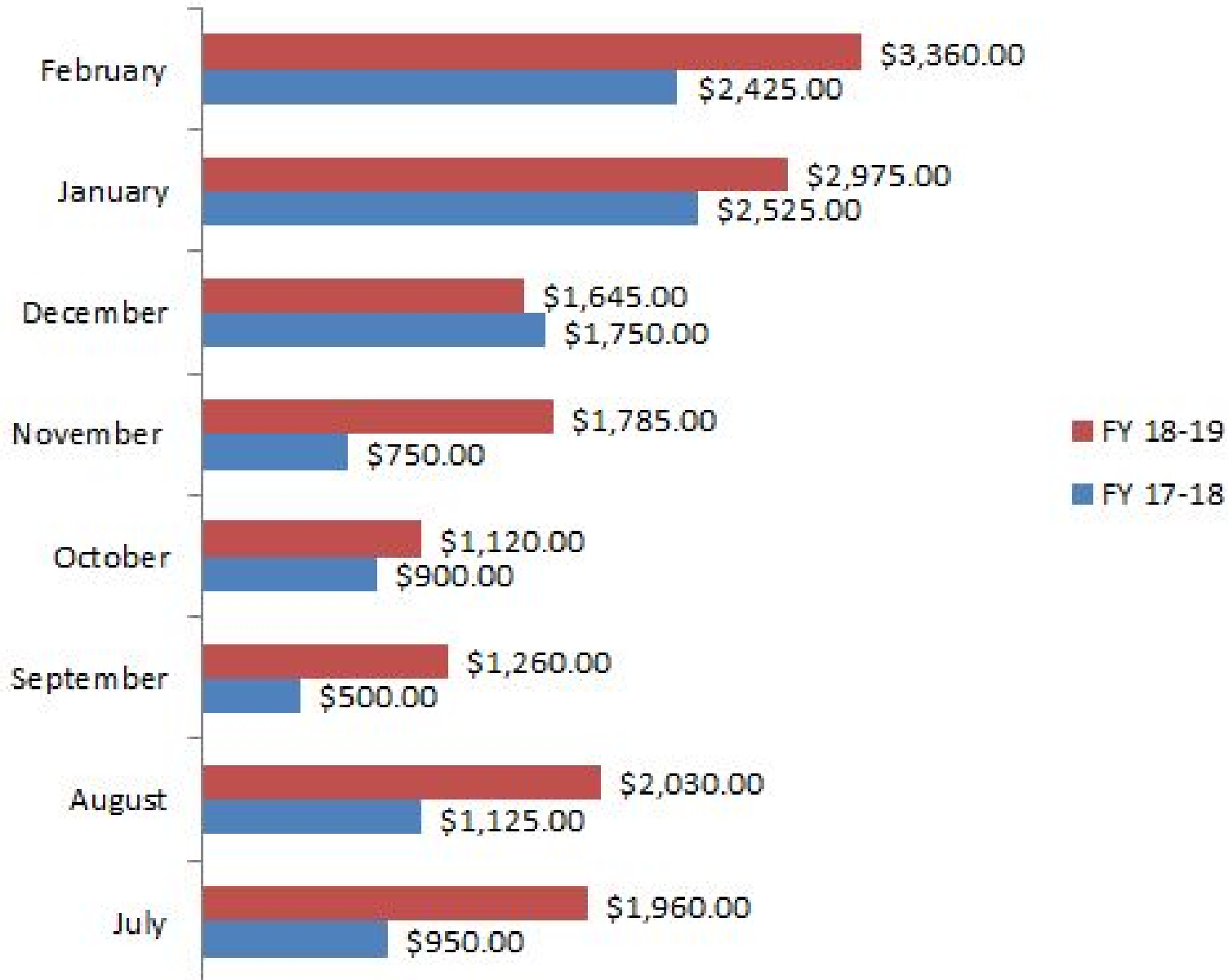
If you support or oppose Senate Bill 29 (allows cities with populations of less than 20,000 to impose a regulatory license fee of no more than 5% on the sale of alcoholic beverages), contact Representative Adam Koenig before Wednesday, March 6th. He serves on the House Local Government Committee and KLC this initiative will be heard in their committee on that day. This has already been passed by the Senate. The City of Erlanger does not have a regulatory license fee on alcoholic beverages. If you support this, or do not support it, call 1-800-372-7181 and leave a message for Rep. Adam Koenig.

House Bill 214 (Protects the public by removing peace officer powers of untrained constables. This does not eliminate the position. They will still be able to perform other job duties, including serving summonses, directing traffic, and dealing with animals and livestock. Currently they can pull you over, fine you and even take you into custody. Some have used this power poorly and illegally.) was heard on the House floor and a request for up to four amendments was made. This Bill could be called up at any time. If you support or oppose this bill, contact Rep. Adam Koenig at the number provided above. I do not know what the four proposed amendments are. Passport Fees Collected



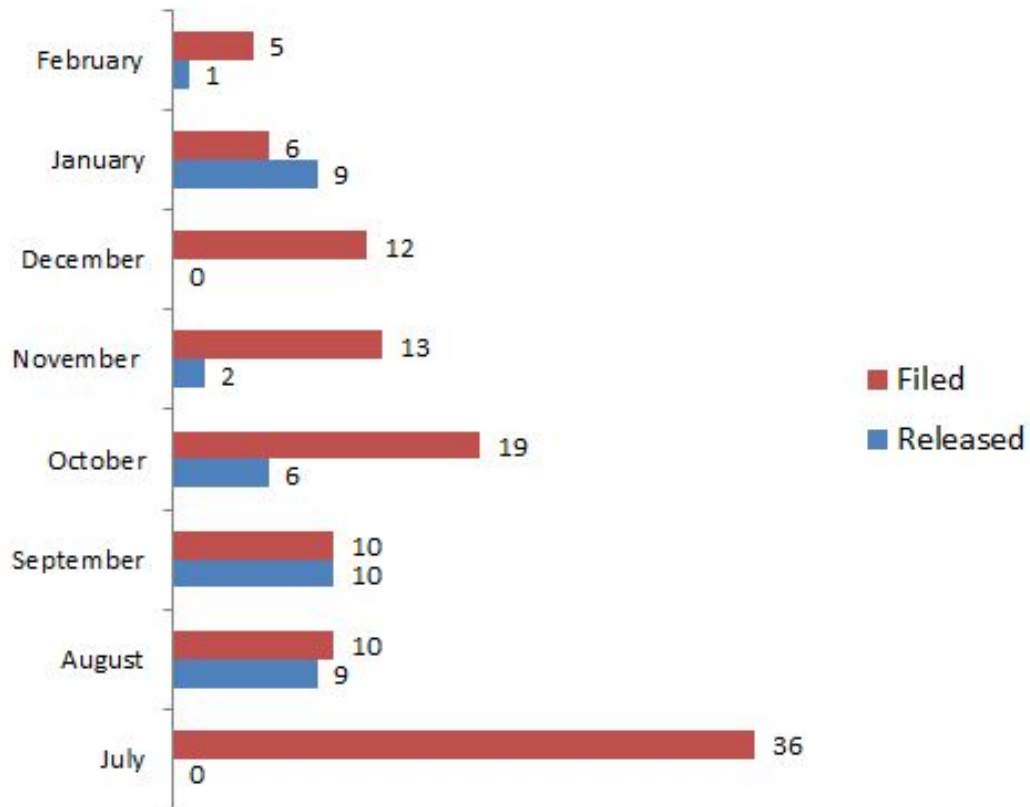
Property Tax Collection FY 18-19
