Narrative: During the month of July, the canine unit assisted the outside agencies Edgewood Police, Covington Police, and the Drug Enforcement Agency (DEA). Sergeant Clark and K9 Bodo remain out on light duty. There is an anticipated return date for Sergeant Clark as of September 1, 2021, but this is not set in stone. Specialist Hartke and Keno continue to carry the bulk of the canine work. The canine unit's yearly national certification with NAPWDA is upcoming in September 2021.

Notable Uses

Comments: Comments: On July 2, 2021 at approximately 1915 hours Officer Hilvert initiated a traffic stop on Interstate 75 south mile marker 183.5. Officer Hilvert requested a K9 for a vehicle sniff. Officer Hartke arrived on scene and deployed K9 Keno; being a nationally certified canine team through NAPWDA and OPOTA to detect odors such as marijuana, methamphetamine, cocaine, heroin, and their derivatives for a vehicle sniff. During the initial pass around the vehicle K9 Keno showed changes of behavior by changes of breathing pattern, gait and change of search pattern at the drivers side rear door, trunk, passenger side rear and front door. During the detail pass around the vehicle K9 Keno showed changes of behavior by change of search pattern, gait, and changes of breathing at the trunk and passenger side rear door. K9 Keno head hooked multiple times changing his search pattern from the passenger side rear door to trunk area. While Officer Hilvert was searching the vehicle; Officer Hartke observed the female passenger retrieve an item from her pocket and attempt to discard it on the ground behind her. Occupants were detained and Officer Hartke retrieved the clear baggie containing suspected methamphetamine. Search of the vehicle yielded a clear pipe with a burnt residue suspected to be methamphetamine in the female's purse on the front passenger floor board. Kimberly Bingaman admitted to the methamphetamine and pipe.

Comments: Comments: On July 4, 2021 at approximately 1927 hours officers were dispatched to 622 Debbie Lane for an domestic violence assault with injuries. While enroute officers were advised the male Michael Maness had left on foot intoxicated. Officers arrived on scene and were able to gather information for charges of strangulation and assault 4th domestic violence. K9 Officer Hartke advised Corporal O'Hara to begin setting up a perimeter to track the suspect. Corporal O'Hara called Officer Hartke to advise there was no good starting point and limited personnel due to a stabbing in Elsmere. Officer Hartke arrived on scene and told Corporal O'Hara that I would attempt a track starting at the back door. Officer Hartke deployed K9 Keno at 1947 hours and began casting K9 Keno out behind the rear exit door of 622 Debbie Lane. K9 Keno began to track nose down tail up and waving east towards Stevenson Road. K9 Keno tracked across the asphalt road and in between the grass area of building 3532 and 3507. K9 Keno tracked down a retaining wall and then down a steep hill. K9 Keno began tracking towards the corner of Snappy Tomato Pizza. K9 Keno began circling the asphalt area between Snappy and the grass area. A short time later, Officer Hines located the suspect sitting outside of Snappy Tomato Pizza. Maness was placed under arrest. Officer Hartke interviewed the suspect who stated he left out the back door of 622 Debbie Lane and walked through the parking lot and down the hill. Maness stated he walked towards Snappy and inside to get something to eat. Maness was inside the establishment while the track was taking place.

Comments: On July 21, 2021 at approximately 1948 hours Erlanger Officers initiated a traffic stop on Dixie Highway and Price Avenue. Officer Hilvert requested a K9 for a vehicle sniff. Officer Hartke arrived on scene and deployed K9 Keno; being a nationally certified canine team through NAPWDA and OPOTA to detect odors such as marijuana, methamphetamine, cocaine, heroin, and their derivatives for a vehicle sniff. During the initial pass around the vehicle K9 Keno showed changes of

behavior by changes of breathing pattern and gait at the drivers side door. K9 Keno showed changes of behavior by changes of search pattern, gait, and change of search pattern at the passenger front and rear door. During the detail pass around the vehicle K9 Keno showed changes of behavior by change of search pattern, gait, and changes of breathing at the drivers side front door, passenger front and rear door. K9 Keno began to lick the rear passenger door handle and take deep nose breaths. Search of the vehicle yielded no illicit drugs. The driver took her purse and was clutching the purse tight to her. Officer searched the purse and located in the wallet a clear piece of twisted plastic with a white powdery substance. Driver stated that it was cocaine. Officer located inside the purse a package of marijuana. Driver admitted to using multiple drugs for a while.

Criminal Investigative Division

This month detectives worked with the Department of Homeland Security on a multi-state investigation. I and Detective Loos attended a two-week homicide course taught by the Southern Police Institute(SPI). The course of study included Crime Scene Evaluation and Analysis, Behavioral Analysis for Homicide, Forensic Evidence and Crime Scene Collection, Blood Stain Pattern Evidence, and legal issues. Detective Loos also conducted Active Shooter Training with both the Erlanger and Elsmere Police Departments. He also will be conducting Active Shooting Training with Erlanger/Elsmere Schools as well.

Training / Evidence Management

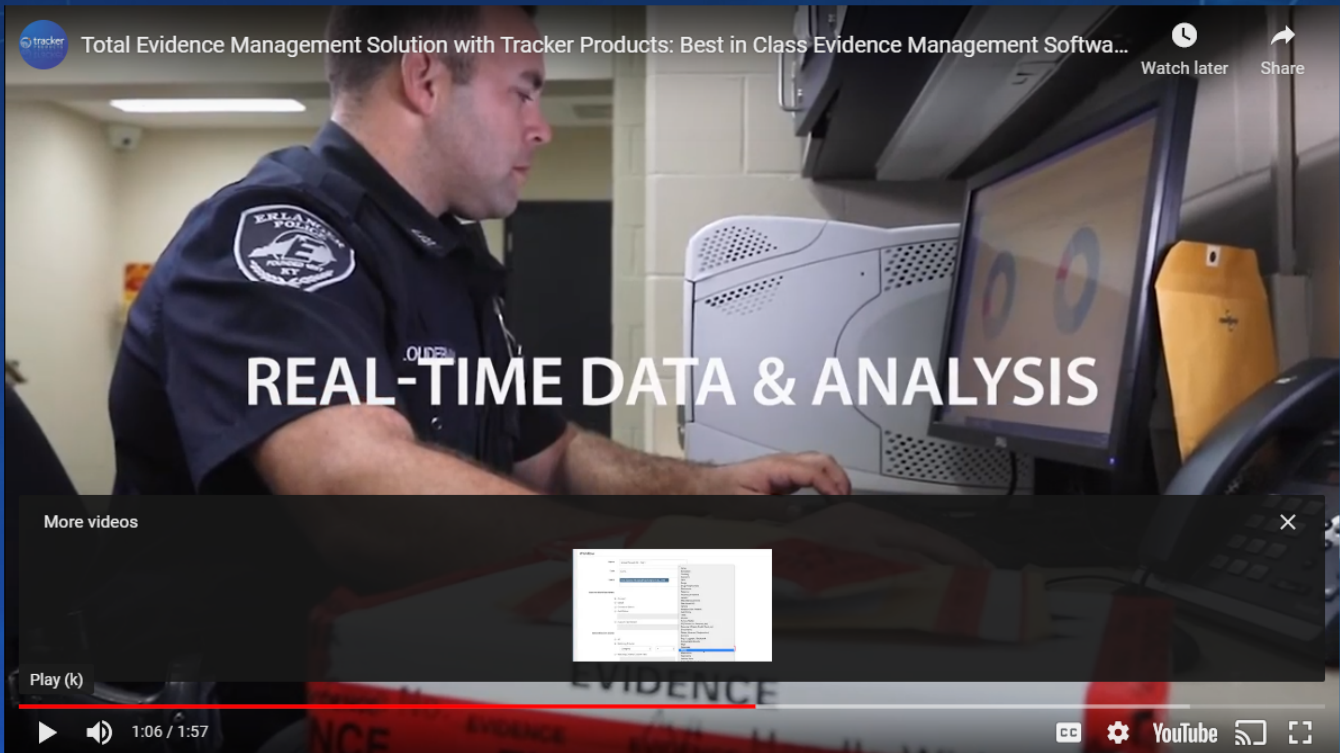

This suit allows officers to conduct more realistic training that involves de-escalation techniques, depending on the training scenario given.



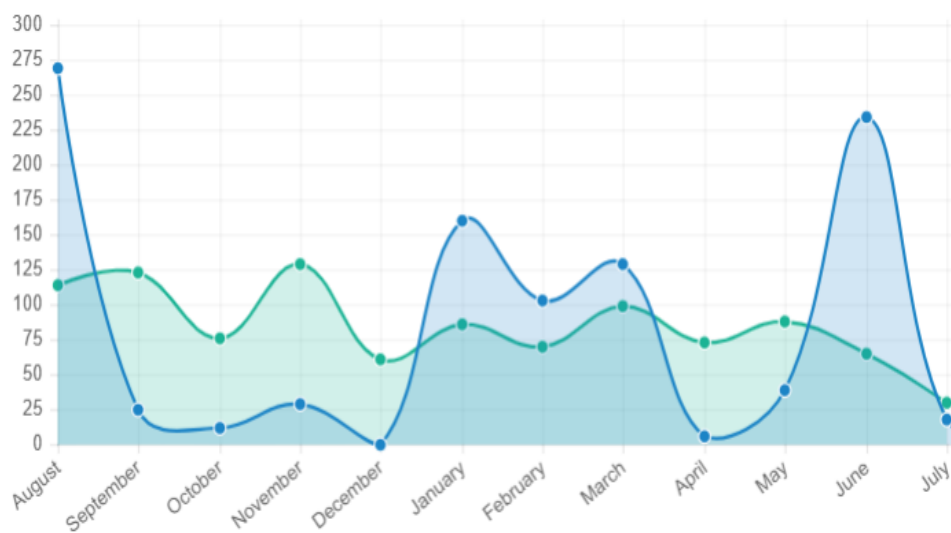

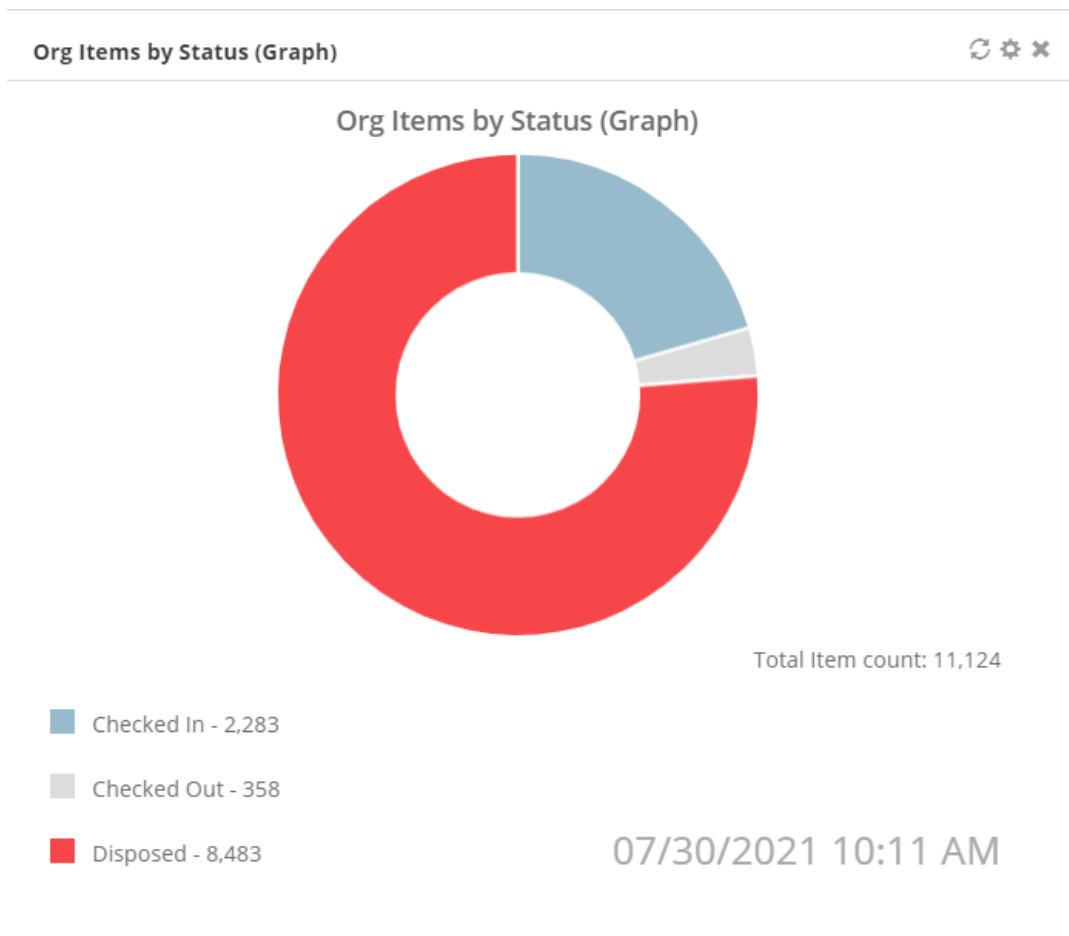
Org In v/s Disposed (Graph)
