CAUCUS DISCUSSIONS

Brewery Text Amendment Ordinance - Mayor Jessica Fette

- > Discussion
 - Recommended making it a conditional use so that hearing requests would go before the Board of Adjustment; this was not discussed at the Kenton County Planning Commission's (KCPC) public hearing
- Action Requested
 - City of Erlanger conduct a public hearing to discuss making it a conditional use or resubmit to KCPC so they could hold another public hearing; no response from City Council

Fiscal Year 2023 Tax Rates - Mayor Jessica Fette

- > Discussion
 - 1. Mayor Fette recommended the following tax rates
 - A. 0.301 for real property, which was the compensating rate
 - B. 0.296 for personal or tangible property, which was less than compensating rate
 - 2. Council recommended the following:
 - A. Compensating rate + 2% for real property (Meyer, Jasper-Lucas)
 - B. Compensating rate for real property with decreased spending (Reckers)

 - 1. Special Meeting on August 23, 2022 at 7:00 P.M. for the first reading of the tax rate ordinance

Nuisance Ordinance - Police Lieutenant Ryan Atchley

- > Discussion
 - 1. Requested changes to current ordinance to address enforcement issues, recommended changes to mirror the City of Florence's nuisance ordinance
 - 2. Changes would include abatement plans, involve both codes enforcement and police, and invoke conversations with landlords
 - 3. A resident suggested including enforcement of noise
- Action Requested
 - 1. First reading of amended ordinance at the September 6, 2022 regular council meeting

Gap KBI Incentive Ordinance - Economic Development Director Emi Randall

 - 1. Asked Council to consider a 1% credit of the City's Occupational License Fees on new Kentucky resident based jobs created by Gap for a ten year period

 - → Amend the draft ordinance and change Gap Inc.'s investment from \$4.48 million to \$288,896.00
