

**RESOLUTION NO. \_\_\_\_\_**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ERLANGER, KENTUCKY, OVERRIDING MAYOR FETTE'S VETO SUBMITTED TO ERLANGER CITY COUNCIL ON SEPTEMBER 12, 2022 OF THE BUDGET AMENDMENT APPROVED SEPTEMBER 6, 2022.

WHEREAS, the City of Erlanger, Kentucky (the "City") passed an amendment to the FY22-23 Budget on September 6, 2022; and

WHEREAS, the budget amendment provided for the transfer of \$5,000,000 from the general fund unrestricted reserves to the capital fund to be held in reserve; and

WHEREAS, the same budget amendment also restricted the items for which funds within the capital fund may be used; and

WHEREAS, the budget amendment provided for the future ability to ensure roads could continue to be built and that the police and fire departments would have the necessary equipment in the event of an economic downturn; and

WHEREAS, the budget amendment had passed with greater than a simple majority required to pass legislation; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ERLANGER, KENTUCKY AS FOLLOWS:**

**SECTION I**

1. That Erlanger City Council hereby overrides the veto from Mayor Fette submitted to the Erlanger City Council via email on September 12, 2022.

2. If any section, paragraph, clause or provision of this Resolution shall be ruled by any court of competent jurisdiction to be invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the remaining provisions hereof.

3. To the extent any ordinances, orders, resolutions or parts thereof may be in conflict, the provisions of this Resolution shall prevail

**SECTION II**

That this Resolution shall be signed by the Mayor, attested to by the City Clerk, recorded and be effective upon adoption
