

REGULAR MEETING
ERLANGER CITY COUNCIL
November 1, 2022

Mayor Jessica Fette called the regular meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, November 1, 2022.

Brian Nevins, Erlanger Police Chaplain, gave the invocation.


Mr. Gatlin read the first reading of an ordinance determining the standards for noise pollution and assessing penalties and fines.


