2. A line to acknowledge the numbers of Addenda received.

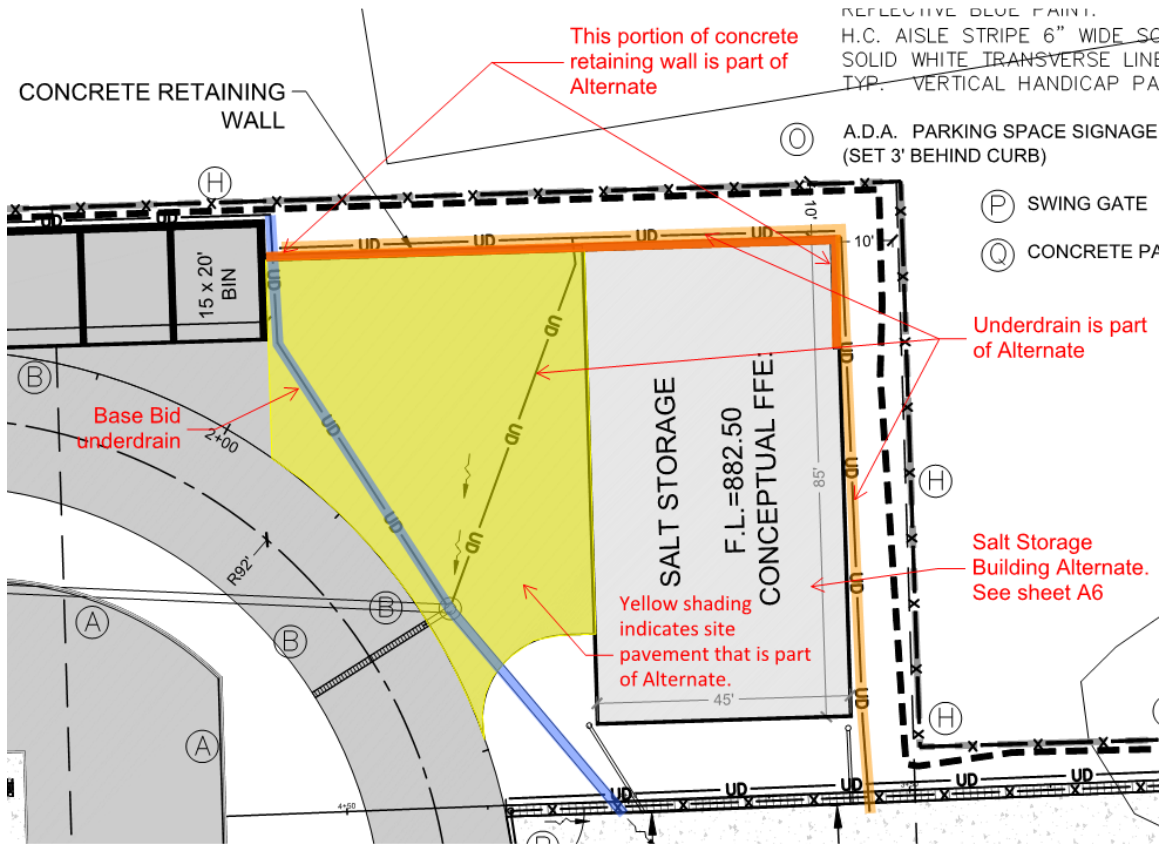
DRAWINGS

1. All work associated with the Salt Storage Building shall be an ADD Alternate and shall be included as a separate cost on the Bid Form reissued with this Addendum.

Refer to Drawing A6 (not reissued): All work indicated on this sheet shall be part of the Salt Storage Building alternate. This includes the walls, roof, floor slab, footings, decoration, etc., as well as the associated design, engineering and permitting.

Refer to the Image on the next page from Sheet 4 of the Civil drawings: The Alternate shall also include the concrete retaining wall extending southeast from the 15x20' material bins up to (and incorporated into) the salt storage building, the underdrain associated with said wall, and site pavement between the salt storage building and the material bins and grading as indicated in Sheet 5 in this same area.

Base Bid grading in this area shall be as required to blend from existing property line grades to base bid installed material storage bins and pavement.
