

REGULAR MEETING  
ERLANGER CITY COUNCIL  
February 7, 2023

Mayor Jessica Fette called the regular meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, February 7, 2023.

Andrew Singh, Erlanger United Methodist Church Minister, gave the invocation.

Members of City Council and citizens pledged allegiance to the flag.

The following Members of City Council were present: Tom Cahill, Vicki Kyle, Jennifer Jasper-Lucas, Diana Niceley, Rebecca Reckers, Renee Skidmore, and Renee Wilson. Council Members Tyson Hermes and Don Skidmore were not present.

Also present were: Mayor Jessica Fette, Chief of Police Kyle Rader, City Administrator Bill Wulfeck, City Clerk Sherry Hoffman, Director of Economic Development/ACAO Emi Randall, Director of Finance Kara Kramer, Public Works Director Peter Glenn, Fire/EMS Chief Randy Godsey, City Engineer Jim Viox, and City Attorney Jack Gatlin.

MEETING MINUTES – M/S, Reckers-Kyle, that the minutes of the regular council meeting held on January 3, 2013 and the special council meeting held on January 31, 2023 be approved as written. All ayes, no nays, motion carried.

APPROVAL OF AGENDA - M/S, Jasper Lucas-Reckers, to table the section of the budget amendment ordinance regarding the movement of \$217,820 from the General Government/Building Zoning budget to the Public Works budget. Discussion followed. Mr. Gatlin advised that the ordinance could not be split and would need City Council to vote to amend the ordinance to include the \$2,000,000 and remove the \$217,820. Ms. Jasper-Lucas withdrew her motion.

M/S, Kyle-Niceley, that the agenda be approved as presented. All ayes, no nays, motion carried.

SPECIAL PRESENTATIONS – Lee Crume, President & CEO of Tri-Ed, was joined by Sydney Murray, Kristin Russell, and David McAleese. They spoke about economic development, strategy, growth, costs, and goals.

Police Lieutenant Kim Klare provided an Erlanger Traffic Safety presentation, which included the following:

- Grant partnership with the Kentucky Office of Highway Safety
- Partnerships with five other cities along the I-75 corridor
- Goal to slow down traffic and reduce injury collision on I-75
- Funding for the program comes from federal grants

LEGISLATION - Mr. Gatlin read the first reading of an ordinance amending Section 96.29 of the Erlanger Code of Ordinances and Ordinance Number 2343 related to restrictions of use of organized athletic teams at Flagship Park.

M/S, Jasper Lucas-Reckers, to strike from the budget amendment ordinance the movement of \$217,820 from the General Government/Building Zoning budget to the Public Works budget. Discussion followed. One aye (Jasper Lucas), six nays (Cahill, R. Skidmore, Kyle, Wilson, Niceley, Reckers), motion failed. Mr. Gatlin read the first reading of an ordinance amending Erlanger Ordinance Numbers 2542, 2543, and 2548 and the budget adopted thereby for the City of Erlanger for the fiscal year beginning on July 1, 2022 and ending on June 30, 2023.


