Mr. Gatlin read the second reading of Ordinance No. 2554 amending Erlanger Ordinance Numbers 2542, 2543, and 2548 and the budget adopted thereby for the City of Erlanger for the fiscal year beginning on July 1, 2022 and ending on June 30, 2023. M/S, Cahill-Niceley, to adopt the ordinance as read. Eight ayes (Hermes, Cahill, R. Skidmore, Kyle, Jasper-Lucas, Niceley, Reckers, D. Skidmore), one nay (Wilson), motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2555 amending section 92.01 of the Erlanger Code of Ordinances updating the Uniform Fire Code adopted to the 2018 edition. M/S, Cahill-Hermes, to adopt the ordinance as read. All ayes, no nays, motion carried.

Mr. Gatlin read Municipal Order No. 03-07-23-01 making the written determinations required by KRS 82.083 for the sale or other disposition of property owned by the City. M/S, Cahill-Reckers, to adopt the municipal order as read. All ayes, no nays, motion carried.

Mr. Gatlin read Municipal Order No. 03-07-23-04 accepting the re-appointment of Marcus Carey, Darryl Cumins, Robert Sanders, Tom Quirk, Bryce C. Roades, and Jack Westwood and the appointment of James Dady as members of the Northern Kentucky Regional Ethics Authority Enforcement Committee for a two-year term, commencing February 1, 2023 and expiring on January 31, 2025. M/S, Jasper Lucas-Kyle, to adopt the municipal order as read. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 03-07-23-01 supporting the passage of House Bill 343 relating to universal recognition of occupational licenses. M/S, Kyle-Hermes, to adopt the resolution as read. Five ayes (Hermes, Kyle, Wilson, Niceley, Reckers), four nays (Cahill, R. Skidmore, Jasper-Lucas, D. Skidmore), motion carried.

ANNOUNCEMENTS - Mayor Fette and Director Glenn presented to Mr. Cahill a framed plan for Cahill Commons in memory of former Councilwoman and employee Kathy Cahill.
