SPECIAL MEETING ERLANGER CITY COUNCIL July 11, 2023

Mayor Jessica Fette called the special meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, July 11, 2023.

Sheri Jackson, Erlanger Christian Church, gave the invocation.

Members of City Council and citizens pledged allegiance to the flag.

The following Members of City Council were present: Tom Cahill, Tyson Hermes, Jennifer Jasper-Lucas, Diana Niceley, Rebecca Reckers, Don Skidmore, Renee Skidmore, and Renee Wilson. City Council Member Vicki Kyle was not present.

Also present were: Mayor Jessica Fette, Chief of Police Kyle Rader, City Administrator Peter Glenn, City Clerk Sherry Hoffman, Director of Finance Kara Kramer, Director of Public Works Kevin Quinn, Fire/EMS Chief Randy Godsey, and City Attorney Jack Gatlin.

MEETING MINUTES – M/S, Reckers-Niceley, that the minutes of the regular council meeting held on June 6, 2023 be approved as written. All ayes, no nays, motion carried.

APPROVAL OF AGENDA -

M/S, Wilson-Jasper Lucas, to approve the agenda as presented. A non-roll call vote was taken. Mayor Fette stated that not everyone responded and requested a roll call vote. Two ayes (Hermes, Wilson), six nays (Cahill, R. Skidmore, Jasper-Lucas, Niceley, Reckers, D. Skidmore). Discussion followed. Mr. Gatlin suggested that instead of not passing the agenda, to remove the legislative items City Council did not want to be read.

M/S, Reckers-Cahill, that the agenda be approved with the requested amendments. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 07-11-23-01 authorizing the execution of a leasehold mortgage with a fee joinder related to a mortgage granted by 660 Erlanger road, LLC to its lender, and other documents related thereto. M/S, Hermes-Reckers, to adopt the resolution as read. All ayes, no nays, motion carried.
