REGULAR MEETING ERLANGER CITY COUNCIL September 5, 2023

LEGISLATION - Mr. Gatlin read the first reading of an ordinance (Resilience Fund Ordinance) repealing in its entirety Ordinance No. 2548 which transferred \$5,000,000 to the capital fund and replacing with a comprehensive fund balance policy.

Mr. Gatlin read the first reading of an ordinance providing for the annual assessment of all real estate and personal property within the City of Erlanger, which is subject to taxation thereby, for the fiscal year beginning on July 1, 2023, and ending on June 30, 2024, and providing for the payment and collection of such taxes, and the penalties and interest thereon; and describing the purpose for which the taxes so collected shall be appropriated and used, and continuing to fund a special fund, called the Park Improvement Fund to support the ongoing development of new and existing parks.

Mr. Gatlin read the first reading of an ordinance amending Ordinance No. 2556 and the pay plan to change and add job titles and pay bands.

M/S, Cahill-Jasper Lucas, to table the reading of the Amended Sidewalk Grant Agreement resolution. All ayes, no nays, motion carried.
