

SPECIAL MEETING
ERLANGER CITY COUNCIL
April 16, 2024

Mayor Jessica Fette called the special meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 6:45 P.M., Tuesday, April 16, 2024.
