Street Light Audit


A PW's team member performed a quarterly street light "audit" in April. This requires the team member to work through the overnight hours in order to get an accurate assessment of lights that may be out or malfunctioning (going on and off repeatedly). April's audit yielded 23 street lights in need of attention, 9 reported to Duke Energy and 14 to Owen Electric.

CAPITAL PROJECTS

New Public Works Facilities

Work continues on the Maintenance Building portion of the new facility along with framing on the Administration Building. The detention area walls are complete with backfill and floor to follow. This project should really start to take shape over the next couple of months.

Street Reconstruction Projects

The Northway Drive, Pleasure Isle Drive, and Circlewood Drive project (new asphalt surface with sidewalk and apron replacement) started on Tuesday March 19th, doing the concrete portion of the project. The contractor started on Circlewood Drive at Heartwood Lane and have finished the one side and started back on the other side and are 40% complete.

The Kingsburg Court project (full concrete street replacement with sidewalk improvements) started on April 18th with the contractor replacing bad sections of sidewalk and started on the first section of street on Monday the 22nd.

The Short Hill Lane, Clover Avenue, Alice Street, and Thomas Street project (new asphalt surface with sidewalk improvements) was awarded to Riegler Blacktop with a start date of late April to early May.

Railroad Underpass

We finally received the right to proceed with the painting of the underpass from Norfolk Southern and are scheduled to begin work on June 2nd, 2024. This project is schedule for approximately 3 weeks and will take place during the overnight hours to better maintain traffic.

Capital Park Improvements

Playground equipment, fencing and the basketball court has been installed at Cahill Commons, the basketball court asphalt needs to sit for 30 days prior to having the surface color applied and striping. Playground mulch has been order and should be installed very soon.

John P. Tumlin and Sons have been awarded the contract for Silverlake Park Phase 3. This will include electric, shelters, and concrete path along tennis court. This project will be starting soon.









