PROGRAMS

Street Light Assessment


The PW's department conducted it's quarterly street light check. This quarterly street light check yielded **8** lights that needed attention. **6** of these lights were reported to Duke Energy and **2** was reported to Owen Electric to have repaired.

Mowing

The Public Works team members have been busy mowing the City's parks and right of ways. A crew of 4 team members are scheduled to cut all the parks and right of ways every week. PW crews have worked **388** man hours to keep our parks and right of ways looking exceptional.

Facility Services

The PW's department has ongoing programs when it comes to cleaning and maintenance within the facilities. Some things are done dailey, weekly, monthly, quarterly and even yearly. Daily and weekly cleanings consist of a team member utilizing **34** man hours a week to clean the City Building and Police Dept. and **4** man hours to clean the PW's facility. Examples of the other schedules are; Garage door inspection and lubrication is done 3 times a year and takes **24** man hours to complete, Rooftop drains and gutters are inspected and cleaned on a monthly basis that takes **2** man hrs to complete. The PW's department also checks fire extinguishers and the circulation pump monthly. A lot of things that most people take for granted.



CAPITAL PROJECTS

New Public Works Facilities

Work continues on all aspects of the new facility, electrical, plumbing and HVAC are moving right along and most of the drywall has been installed in the administration building. The salt storage building concrete walls have been poured with the floor and roof to follow along with the material storage bins underway.

Street Reconstruction Projects

The first street project of the new fiscal year went out to bid with the bids being opened on 8/1/2024. This project will see full concrete street replacements on Hayden Drive and Yager Court.

Annual Programs

There are three programs that the Public Works Department puts out to bid annually and they are Sidewalk Replacement, Crack Sealing and Street Striping.

Sidewalk Replacement Program

The sidewalk replacement contract was awarded to Humphrey Concrete. The plan is to start back in early fall with completion before the winter months.

Crack Sealing

The crack sealing contract was award to Scodeller Construction. A start date in early spring is expected.

Street Striping

The street striping contract was awarded to A&A Safety with a start date of mid August, 2024. This will see all the long line stripes, stop bars and arrows painted with a KYTC approved traffic paint with reflective glass beads embedded into the paint.


Capital Park Improvements






