### PROGRAMS

#### Sign Replacement Program

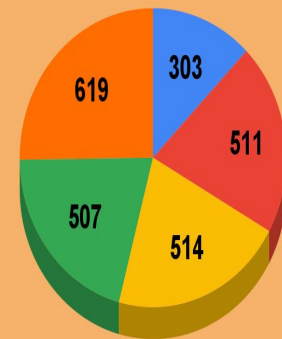
The Public Works Sign Department has been working in zone 3 replacing street ID's. 24 have been changed since July. 174 total street ID's have been changed over to the new design. The old signs have been made available for purchase and all proceeds are donated to the E Angels Program.



#### Mowing

The Public Works team members have been busy mowing the City's parks and right of ways. A crew of 4 team members are scheduled to cut all the parks and right of ways every week. PW crews have worked 303 man hours to keep our parks and right of ways looking exceptional. August has been relatively hot and dry. The Public Works Department has also been continuously watering the new installs at Cahill Commons and the new trees throughout the city.

### CAPITAL PROJECTS

#### New Public Works Facilities

Work continues on all aspects of the new facility with the rough in electrical, plumbing, and HVAC being complete with just the finish work to be done. All of the drywall has been installed in the administration building and has the first coat of paint applied. The tracks for the ceiling are going in and the floor has been polished and sealed. The salt storage building has been painted and the roof is close to completion. The maintenance building is complete with just punch items to complete. The fence around the facility is going in and the concrete lot is being poured in sections.

#### Street Reconstruction Projects

The first couple of street projects of the new fiscal year went out to bid, with the bids being opened in August. The first project will see full concrete street replacements on Hayden Drive and Yager Court. The contract was awarded to Jefferson Contracting with a tentative start date of mid October. The second project will be an asphalt overlay on Theodore Court with the contract being awarded to Riegler Blacktop, but no start date has been set.

#### Annual Programs

There are three programs that the Public Works Department puts out to bid annually and they are Sidewalk Replacement, Crack Sealing, and Street Striping..

#### Sidewalk Replacement Program

The sidewalk replacement contract was awarded to Humphrey Concrete. The plan is to start in early fall with completion before the winter months.

#### Crack Sealing

The crack sealing contract was award to Scodeller Construction. A start date in early spring is expected.

#### Street Striping

The street striping contract was awarded to A&A Safety. This will see all the long line stripes, stop bars, and arrows painted with a KYTC approved traffic paint with reflective glass beads embedded into the paint. A&A completed this project in August.

#### Capital Park Improvements

John P. Tumlin and Sons are still working on the phase 3 portion of Silverlake Park. The concrete path, electric and shelter pads are complete and Duke Energy has installed the new poles to feed power to this end of the park. Shelters are being erected and the rest of the plaza is being poured in sections. The project is expected to be complete by the end of the first week in September.

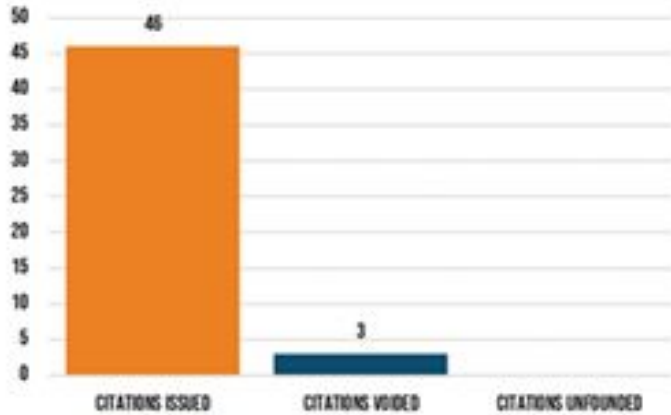

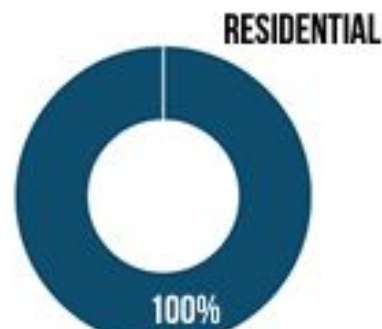

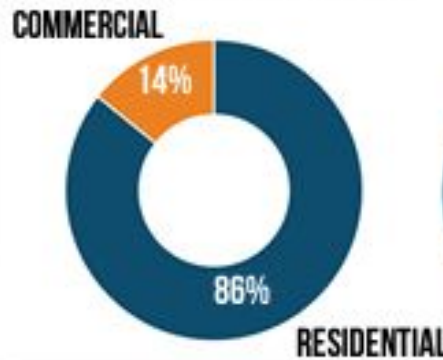
