Cahill Commons Recap - Director of Economic Development/ACAO Collier

Budget Amendment - City Administrator Peter Glenn

- Discussion
 - 1. Four items proposed for amendment
 - A. Vacant Administrative Clerk Position This position would remain vacant with its responsibilities shared among other Administrative employees.
 - B. Finance Accountant Position This position would be created to assist the Finance Department with accounts receivable responsibilities and would utilize the existing salary for the vacant Administrative Clerk position.
 - C. Marketing This was initially funded for six months, but requested additional funding for six additional months.
 - D. Capital Fund
 - 01. Totaled Police Vehicle Replacement
 - 02. Firehouse Station I Feasibility Study Chief Godsey confirmed the department had an in-house committee for this study.

Alice Street Beautification Improvements - Councilwoman Rebecca Reckers

- > Discussion
 - 1. Project
 - A. Previous Recommendation The recommendation of the Beautification Task Force was to install horse fencing for \$5000.00. The check register showed approximately \$20,000 was spent on this project.
 - B. Expense Summary Mr. Glenn explained that there had been a miscoding of the accounts. The total cost for the beautification of this project was \$10,104.00, which included the fencing, trees, grading, mulch, and equipment rental. The total cost for the street maintenance of this project was \$5,500.00, which included sidewalk removal and gravel placement. The beautification and street maintenance were two separate funds.
 - C. Additional Issue Not Resolved Mr. Glenn reported there was an apron issue at this location that needed to be addressed. It was discussed at the September Beautification meeting. The repair costs for this project would come out of the street maintenance fund, not the beautification fund.
 - D. Remaining Beautification Budget Approximately \$42,000 remained in the budget.

 - 1. Notification of Projects Prior to the start of the apron project, the project and cost should be discussed at a Beautification Task Force meeting, so the task force could report the information at a caucus meeting.
