

SPECIAL MEETING  
ERLANGER CITY COUNCIL  
November 19, 2024

Mayor Jessica Fette called the special meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 6:45 P.M., Tuesday, November 19, 2024.

The following Members of City Council were present: Tyson Hermes, Jennifer Jasper-Lucas, Diana Niceley, Rebecca Reckers, Don Skidmore, Renee Skidmore, and Renee Wilson. Council Members Tom Cahill and Vicki Kyle were not present.

Also present were: Mayor Jessica Fette, Chief of Police Kyle Rader, City Administrator Peter Glenn, City Clerk Sherry Hoffman, Director of Economic Development/ACAO Mark Collier, Director of Finance/HR Kara Kramer, Public Works Director Kevin Quinn, Fire/EMS Chief Randy Godsey, and Attorney Sebastian Torres.

SPECIAL PRESENTATIONS – Mayor Fette proclaimed November 30, 2024 as Small Business Saturday Day in the City of Erlanger.

Brandon Faris presented a video highlighting Erlanger Business El Ocho Loco and its owner Luis Diaz.

LEGISLATION - Mr. Torres read the second reading of Ordinance No. 2578 amending Erlanger Ordinance Number 2574 and the budget adopted thereby for the City of Erlanger for the Fiscal Year beginning on July 1, 2024 and ending on June 30, 2025. M/S, Reckers-Niceley, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Torres read the first reading of an ordinance amending the Erlanger Zoning Ordinance adding “Tattoo Parlors” as a conditional use within the MU (Mixed Use) zone.

Mr. Torres read the first reading of an ordinance confirming the sale and awarding a non-exclusive telecommunications franchise to Cincinnati Bell Extended Territories LLC (DBA Altafiber Connected) for the placement of cable systems providing for the transmission, distribution and sale of cable systems within the public right-of-way of the City of Erlanger, for an initial period of five (5) years from the effective date with a possible (5) year renewal; and further providing for compliance with relevant laws, regulations and standards; usage limitations, indemnification, insurance, cancellation or termination, and such other terms and conditions contained in the attached cable services franchise agreement; and bid requirements; all effective on date of passage.
