


PROGRAMS

2024 Trash Collection

One of PW's main jobs is to pick up trash in the city parks, highway trash cans, and all the city's right of ways, keeping Erlanger the cleanest city in the area. PW's crews utilized **592** man hours picking up **1430** bags of trash while driving **2836** miles throughout the city.

The State of Kentucky has a grant program for picking up litter. The City applies for a Litter Abatement Grant every year with the application being due November 1st, which applies to the next calendar year. During the year, records must be kept on how many man hours were used to pick up litter, how many bags of litter were picked up, and how many miles were driven to pick up litter. A report is then sent to the Division of Waste Management in Frankfort in February outlining those details of that previous years Litter Program. The City received \$ 9,215.28 this year.



Christmas Tree Recycling

The annual Christmas Tree recycling program was completed on January 15th, 2025. There were a total of **29** trees dropped off this year. The trees were mulched by Kenton County Public Works and will be disbursed among several county parks as bedding and for walking paths.

Street Light Assessment

The PW's department conducted it's quarterly street light check. The quarterly street light check yielded **20** lights that needed attention. **13** of these lights were reported to Duke Energy and the other **7** were reported to Owen Electric to have repaired.

Weather Warriors

The Weather Warriors were called into action for **2** weather events in January. Both events were for a measurable snowfall totaling about 15 inches. The crews utilized **524** tons of bulk salt at a cost of **\$42,575.00** and **444** man hours spread over **7** shifts.

CAPITAL PROJECTS

New Public Works Facilities

The old Public Works Facility is slowly being transferred to the new facility. All of the admin/office supplies have been moved with the admin team working from the new facility permanently. The crews continue to move equipment, supplies, and material from the old facility to the new building as time allows.

Street Reconstruction Projects

Yager Court is on tap for a full replacement with sidewalks and aprons but is on hold until the weather becomes more favorable towards early spring. This project will be completed by Jefferson Contracting.

Kentaboo Avenue and Virginia Avenue went out to bid. The bids were opened in December with Jefferson Contracting being awarded the contract. This project is expected to start in early spring.

Sidewalk Replacement Program

The sidewalk program is on winter break. The work will continue when the weather improves in early spring and the contractor will then continue in the Cherry Hill subdivision.

Park Projects






