ERLANGER CITY COUNCIL
June 3, 2025

Mayor Jessica Fette called the regular meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, June 3, 2025.

B.J. Donahue with the Erlanger Baptist Church gave the invocation.

- Cave Run Map Amendment - He introduced Andy Videkovich with the Planning Development Services of Kenton County (PDS) who advised on the Kenton County Planning Commission's (KCPC) favorable recommendation.
- KDPI Grant Resolution - The City applied for this site preparation grant in 2024; the resolution was to confirm the City would pay 20% of the grant and work with an engineer.

LEGISLATION - Mr. Gatlin read the first reading of an ordinance adopting a budget for the City of Erlanger for the Fiscal Year beginning on July 1, 2025, and providing that no monies shall be expended by or on behalf of the City of Erlanger except in accordance with that adopted budget.

Mr. Gatlin read the first reading of an ordinance establishing a personnel pay and classification plan for all Erlanger employees and non-elected city officers.

Mr. Gatlin read the first reading of an ordinance amending Section 33.07 of the Erlanger Code of Ordinances adding the position of Director of Public Safety.

Mr. Gatlin read the first reading of an ordinance amending the zoning map of the City of Erlanger, County of Kenton, area of approximately 1.94 acres on the southwest side of Cave Run Drive between Dixie Highway to the Southeast and Barkley Drive to the Northwest, approximately 415 feet Northwest of Dixie Highway in Erlanger, from R-M (Residential Mixed) Zone to NC (Neighborhood Commercial) Zone.

Mr. Gatlin read the first reading of an ordinance approving and adopting a supplement to the Code of Ordinances of the City.

Mr. Gatlin read Municipal Order No. 06-03-25-01 amending the City of Erlanger Personnel Policies related to job descriptions creating the position of Director of Public Safety. M/S, Hermes-Farmer, to adopt the municipal order as written. All ayes, no nays, motion carried.

Mr. Gatlin read Municipal Order No. 06-03-25-02 amending the City of Erlanger Personnel Policies related to job descriptions creating the position of Community Engagement Coordinator. M/S, Reckers-Wilson, to adopt the municipal order as written. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 06-03-25-01 authorizing the City to provide local match funding and serve as the grantee with the Kentucky Product Development Initiative (KPDI) grant as awarded for the Industrial Park South Project. M/S, Jasper Lucas-Reckers, to adopt the resolution as written. All ayes, no nays, motion carried.
