

SPECIAL MEETING
ERLANGER CITY COUNCIL
June 10, 2025

Mayor Jessica Fette called the special council meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 6:45 P.M., Tuesday, June 10, 2025.

The following Members of City Council were present: Tom Cahill, Chris Farmer, Michele Fields, Jennifer Jasper-Lucas, Diana Niceley, Rebecca Reckers, Renee Skidmore, and Renee Wilson. Council Member Tyson Hermes was not present.

Also present were: Mayor Jessica Fette, City Administrator Peter Glenn, Director of Economic Development/ACAO Mark Collier, City Clerk Sherry Hoffman, and City Attorney Jack Gatlin.

LEGISLATION - Mr. Gatlin read the second reading of Ordinance No. 2582 adopting a budget for the City of Erlanger for the Fiscal Year beginning on July 1, 2025, and providing that no monies shall be expended by or on behalf of the City of Erlanger except in accordance with that adopted budget. M/S, Farmer-Reckers, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2583 establishing a personnel pay and classification plan for all Erlanger employees and non-elected city officers. M/S, Niceley-Wilson, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2584 amending Section 33.07 of the Erlanger Code of Ordinances adding the position of Director of Public Safety. M/S, Jasper Lucas-Reckers, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2585 amending the zoning map of the City of Erlanger, County of Kenton, area of approximately 1.94 acres on the southwest side of Cave Run Drive between Dixie Highway to the Southeast and Barkley Drive to the Northwest, approximately 415 feet Northwest of Dixie Highway in Erlanger, from R-M (Residential Mixed) Zone to NC (Neighborhood Commercial) Zone. M/S, Reckers-Farmer, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2586 approving and adopting a supplement to the Code of Ordinances of the City. M/S, Fields-Farmer, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 06-10-25-01 proposing to acquire, develop, and/or renovate recreational resources to provide for the health and well being of the general public, intending to make application to the Department for Local Government for assistance under the Land and Water Conservation Fund Act of 1965, and holding in reserve fifty percent of the proposed project cost for the purpose of matching the Land and Water Conservation Fund assistance. M/S, Niceley-Wilson, to adopt the resolution as written. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 06-10-25-02 proposing to acquire, develop, and/or renovate recreational resources to provide for the health and well being of the general public, intending to make application to the Department for Local Government for assistance under the Recreational Trails Program, and holding in reserve twenty percent of the proposed project cost for the purpose of matching the Recreational Trails Program assistance. M/S, Reckers-Jasper Lucas, to adopt the resolution as written. All ayes, no nays, motion carried.
