REGULAR MEETING ERLANGER CITY COUNCIL September 2, 2025

NEW BUSINESS - Mayor Fette canceled the September 16, 2025 caucus meeting due to there being no topics for discussion.

LEGISLATION - Mr. Gatlin read the second reading of Ordinance No. 2587 amending the zoning map of the City of Erlanger, County of Kenton, an area of approximately 1.26 acres, located at 3208 Dixie Highway, North of Dixie Highway and South of the railroad in Erlanger, from CC (Community Commercial) Zone to GI (General Industrial) Zone. M/S, Reckers-Farmer, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read the second reading of Ordinance No. 2588 providing for the annual assessment of all real estate and personal property within the City of Erlanger, which is subject to taxation thereby, for the fiscal year beginning on July 1, 2025, and ending on June 30, 2026, and providing for the payment and collection of such taxes, and the penalties and interest thereon; and describing the purpose for which the taxes so collected shall be appropriated and used, and continuing to fund a special fund, called the park improvement fund to support the ongoing development of new and existing parks. M/S, Hermes-Farmer, to adopt the ordinance as written. All ayes, no nays, motion carried.

Mr. Gatlin read Resolution No. 09-02-25-01 directing the Mayor or City Administrator to apply to the Kenton County Planning Commission to remove detached garages as a requirement in the R-MF Zone. M/S, Reckers-Hermes. Discussion followed regarding previous enforcement. All ayes, no nays, motion carried.
