REGULAR MEETING ERLANGER CITY COUNCIL November 4, 2025

Mayor Jessica Fette called the regular meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, November 4, 2025.
